


1. The contractor has changed their name to **Babcock Wilcox Technical Services Y-12, LLC (B&W Y12)** in accordance with FAR Part 42.1203. The Government's and Contractor's rights and obligations remain unaffected by this action. Any cost solely caused by the execution and implementation of the name change shall be at no cost to the Government. Contract DE-AC05-00OR22800 is hereby modified to delete all references of **BWXT Y-12** and substitute the new company name.
2. Pursuant to the provisions of Clause I.144, the first sentence of paragraph (a) is hereby changed to read as follows: "The amount presently obligated by the Government with respect to this contract is \$5,357,653,023.15.

This represents an increase of \$53,716,376.61 from \$5,303,936,646.54 to \$5,357,653,023.15 (\$3,416,296,389.13 obligated by Oak Ridge Office and \$1,941,356,634.02 obligated by the NNSA Service Center). \$3,100,000 of the total obligated amount is for transition activities. This change is the result of a net increase by the NNSA Service Center on FY 2008 Approved Funding Programs No. 2 and 3.

All other terms and conditions remain unchanged.
