


The funds authorized for this Work Authorization Directive (WAD) are subject to the following:

Baseline Value: \$216,037,378.00 (May 7, 2009 to September 30, 2011)

Authorization Value \$270,299,243.00

Limitation of Cost: \$108,018,688.00

Pursuant to the clause B.04 and H.19, entitled "Work Authorization System" total funds in the amount of \$216,037,378.00 are authorized for the performance of this WAD and made available for payment of allowable costs and fee earned related only to the Recovery Act work from May 1, 2009 through September 30, 2011. The contractor is approved to incur costs up to \$108,018,688.00 (Limitation of Cost amount) of the Authorization Value of the WAD. Included in the baseline of the \$216,046,000.00, the following fee has been negotiated: 2009 will have a 4% award fee; while 2010 and 2011 will have a 6% award fee with Performance Based Incentives that will be addressed in an ARRA Performance Evaluation Plan.
